## TERMS AND CONDITIONS

1. NO FEES OR PACKAGES ARE REFUNDABLE.

We will keep to our side of the contract by giving you the service you paid for. Only where persons need to leave Kimberley permanently, we <u>may</u> consider a refund if you let us know in time, but a cancelation fee needs to be paid. Costs and lessons already taken will be deducted. The Doxa Direction still have the last say.

- 2. NO lesson/classes/Packages paid will be postponed indefinitely. Payment will secure your spot. No classes will be given without payment. We will not reserve any places without payment.
- 3. If you choose the "no classes option", it means, NO classes and NO mocktest. You will be given the link to the appropriate K53 App. If you choose classes you will have to attend one info class and get your study material and you will get one mocktest class.
- 4. Packages are valid for one learners license attempt only.
- 5. Students must get their own ID photos and eye tests and pay for it themselves.
- 6. Doxa will arrange the date of appointment but you will have to come with us in person to book on a suitable day and time.
- 7. If you fail, you will have to book and pay for a second attempt. Costs for a second attempt is **R300** payable before any new booking will be made.
- 8. Doxa may reschedule classes as they see fit or if necessary but you will be notified in time of the new dates.
- 9. **NO** student shall be collected at home or dropped off at home. No exceptions.
- 10. You have to use your own transport to get to 56 Avivaroad, Hillcrest to book your classes etc.
