TERMS AND CONDITIONS

1. Fees must be paid upon registration. No lessons to be booked without a payment. If you paying over a 2 month period, terms are strict 30 days. If payments are not made regularly, lessons will stop. We don't reserve places without payment. Drivers test bookings will only be made after the 2nd payment is received.

2. In the event of any paid packages cancelled within 7 days for whatever reason, Doxa will not be making any refunds.

3. If you cancel your scheduled lessons, you may forfeit it and we are not obliged to give you the lesson at another time. No lessons or applications will be indefinitely postponed. Lessons should be cancelled 48 hours in advance. DOXA cannot promise that we in any case, can assist with another date or time.

4. This package is valid for one attempt of your drivers license. Should you fail you will be responsible for the application fee, car rental and extra lessons for your second attempt.

5. If you are late your lesson will be shorter. Driving lessons are one hour long. We will wait a maximum of 15 minutes and then we will leave. We will not be able to phone you or whatsapp you to remind you of lessons unless we change your schedule.

6. DOXA reserves the right to change your schedule, but we will always give you an alternative date or time for lessons that we have to reschedule.

7. DOXA cannot always give lessons at times and dates that suits the student only. We are trying to accommodate all, but is not always possible. Please help us to find a suitable way.

8. Our packages are inclusive of all fees, but only **one attempt** for both learners and license are included. Your license card issuing fee of R135 is **NOT** included because it is the fee that the DLTC Station charge and it is not a Doxa fee. It is only applicable when you pass your drivers test.

9. Students must have their **ORIGINAL** learners license with them at all times. No learners, means no lesson. **NO COPIES ALLOWED.**

10. Students are responsible for their own ID photos and documentation, eye tests etc. when needed.

11. **DOXA will assist with the booking of the appointments (learners and license), BUT you have to go with us. We cannot make any booking on your behalf.**

12. Drivers Test Bookings will depart from the Doxa Office and you will be taken back to the office afterwards. No pick

ups at home, school etc. No exceptions.

13. Students will be collected for their driving lessons at the address provided on the registration form. It covers the greater Kimberley area only. No pick up at Diskobolos, Yonder, Camelot, Florianville, Galeshewe, Homevale, Homestead etc and further than the testing centre. Please refrain from changing addresses during lessons.

14. Students use the Doxa vehicle for their lessons and their test. If you use your own vehicle, fees remain the same. **We cannot refund if you decide not to use our vehicle anymore.**

15. You need to have the correct documentation ready for every booking. We will provide you with the necessary information. If after the information was given, and a person still does not have the correct documents ready, we will not take such a person to book any appointment until he/she have the correct documents. If you cannot make your appointment, for whatever reason, we will have to charge a R100 fee to take you again.

16. We cannot allow any person to put pressure on us to let them have a test date if that date does not suit us. Nor will we allow any person to put pressure on us to let such a person have lessons, when we don't have availability for such lessons. Instuctors schedules, avialability of vehicles and drivers tests have to be taken into account.

Lesson schedules will always be sent via whatsapp on time. Unnecessary messages are time consuming.

18. It is not Doxa's responsibility to change any test date. Should something happen, the Law states that every person must go to the testing centre themselves and change their own dates. We will not be liable for any extra costs. Doxa WILL NOT change any test date on behalf of any student.

19. Take note: The packages are only valid for 6 months for persons older than 18 and must be completed within this period. If not completed on time, no lessons will be saved or refunded. No Loose lessons available.

The Customer is aware of the risk of learning to drive on the road and will ensure the Customer takes every precaution to protect Doxa's personnel, property and Equipment.

The Customer accepts the conditions of this agreement and voluntarily assume the risk inherent in taking part in the service and will together with the Customer's heirs, executors and administrators hereby release Doxa, its employees, subcontractors and representatives, from any duty or care towards the Customer, in connection with the Customer's participation in the Service, and from liability from all or any claims that could accrue to the Customer or the Customer's heirs, executors and administrators arising out of the Customer's participation in this programme or in any related activities irrespective of whether such claim or claims arose through the negligence of any person, or from any of the risks, dangers or hazards inherent in the service, product, equipment, or of any loss of, or damage to, any property from any cause whatsoever and the Customer further indemnify and hold harmless associated persons against any claims howsoever the same may arise.

The customer shall be liable for all or any damage to Doxa property caused by the customer whilst participating in the service. Doxa shall at its own discretion decide whether or not to repair the damages through an insurance company.
